MISSION STATEMENT: The Quest Academy RAMPAGE Club is a Student Spirit Organization that promotes motivation, belonging, student involvement, community, and school spirit and pride.

CLUB REQUIREMENTS: Members must abide by the following expectations to remain a member of the RAMPAGE club for the entire school year.

1. Maintain a 3.0 GPA each quarter of the school.
2. No more than one "N" (probation) and NO "U's" (dismissal) in Citizenship.
 - a. If a club member receives an "N" in Citizenship marks or below a 3.0 GPA, he/she will be notified of a probationary period until the next term report cards are posted.
 - b. If membership requirements are once again met, the student may remain enrolled.
 - c. If probation has been served and membership requirements are not met, he/she will be dismissed from the club.
1. RAMPAGE members are expected to be representatives of Quest Academy and the highest standards of leadership. This includes good/respectful behavior, respectful (not profane or lude) language, respect of Administration, Teachers, and Staff, and maintaining a personal profile that is in line with Quest Academy and its standards.
2. Cyber Bullying (In any of its forms), cheating, stealing, fighting, and/or any form of disruptive or disrespectful behavior will not be tolerated and will be grounds for immediate dismissal. Social Media posts, likes, and profiles should be positive, respectful of others, and mindful of your own personal professional future.
3. Members of RAMPAGE will be expected to attend weekly meetings, school activities, and home sporting events. It is an essential part of this club to attend these meetings to assist in planning, delegation, and involvement in student activities.
4. Students should not miss a meeting or scheduled activity without having it cleared through Mrs. Schofield first. It is the student's responsibility to communicate with the Advisor (Mrs. Schofield). Excessive absence will result in dismissal.
5. Conduct that is not representative of the RAMPAGE Club and Quest Academy will result in probation or dismissal as per Mrs. Schofield and Administrative consent.
6. We will be purchasing a RAMPAGE Spirit T shirt and a club jacket for the upcoming school year. Students will not receive shirts, jackets, or be able to participate in the RAMPAGE Club without payment. Details TBA at parent meeting once club members are finalized.
